

Australian Pork Limited GUIDELINES for preparing Research Proposals

Application Process

All applications must be prepared and submitted through the APL PigConnect portal https://pigconnect.australianpork.com.au/. If this is your first time submitting an application via the PigConnect portal you will need set up your 'Log in' details prior to the development and lodgement of your proposal. You can do this via the 'Set up an account' tab on the PigConnect homepage.

If you are submitting a proposal in response to a specific 'Request for Proposal' (RFP) your application must address the specific key deliverables and priority areas sought within the RFP document. If you are submitting an 'out of session' proposal that is not responding to a specific RFP, make sure that you have been in contact with the relevant Program Manager (see below) or Dr Rob Smits (General Manager R & I - rob.smits@australianpork.com.au) before submitting your proposal for consideration.

Budget considerations

Personnel (fees)

For competitive applications the inclusion of permanent (tenured) staff salaries into the funding requested from APL increases the price, decreases the attractiveness of the project, and is not encouraged. Where APL funds for salaries is requested, they may include an on-costs loading including payroll tax, workers' compensation, leave loading, long-service leave, non-contributory and contributory superannuation, however items such as extended leave and severance pay should be excluded.

Overheads may be included in the 'Contributions by research organisation or project collaborators' as inkind contributions only. The methods used to calculate overheads should be stated and able to stand the scrutiny of an audit.
