

APL Delegate Nomination Form

For the term September 2022 to September 2025

Before you begin:

Have you completed an APL Membership Application / Slaughter Levy Declaration? You must be a Member of APL to be eligible to nominate a person to stand for election as a Delegate. Ensure your APL Membership Statutory Declaration or Consent to Access PigPass is dated on or prior to the date you complete this form.

Australian Pork Limited (APL) Members may nominate a person to stand for election for appointment as a Delegate to represent all pig slaughter levy payers on certain matters at general meetings of APL. Individuals representing Member organisations may nominate themselves for election as a Delegate.

A Delegate is a 'natural person', meaning they are appointed in their own right as an individual. A Delegate may but need not be a Member or Director. The APL Constitution operates as a contract between APL and the Delegate.

A nominee who has consented to act is appointed as a Delegate when an amount of pig slaughter levy as recorded in the APL membership register, equal to or greater than the 'Delegate Levy Amount', has been voted by one or more Members in favour of appointing a nominee.

The Delegate Levy Amount for the 2022 Delegate Election is \$445,872.

In other words, each whole dollar of levy paid is equal to one 'vote' for a candidate, and each candidate requires 445,872 votes to be appointed as an APL Delegate.

Each APL Member may nominate one or more candidates for election as a Delegate. To nominate more than one candidate, please complete and return an additional copy of this form.

To nominate a Delegate candidate, please complete the following form or nominate a candidate online via the PigPass Portal.

Using the PigPass Portal to select your nominee gives you greater transparency and therefore control over who is appointed. This is done through the allocation of your levy funds as the Portal allows you to view the results in real time and see who has already been allocated votes and / or been appointed.
