

## PIG WHP/ESI LIST

This list comprises of products approved for pigs with withholding periods (WHP) and export slaughter intervals (ESI).

The data should correctly list the WHP and ESI as presented on the label as of August 2025.

Products for which the active is of no residue concerns (such as protein pastes and nutritionals) are excluded from this list.

Many 'older' products have not had an ESI established by the APVMA. However, a WHP/ESI may need to be considered in conjunction with your vet.

While every endeavour has been made to capture all pig products, some products may have been inadvertently omitted.

This list is intended as a guide only and producers and veterinarians are encouraged to check product information on PubCris (<https://portal.apvma.gov.au/pubcris>) or directly with the manufacturer.
